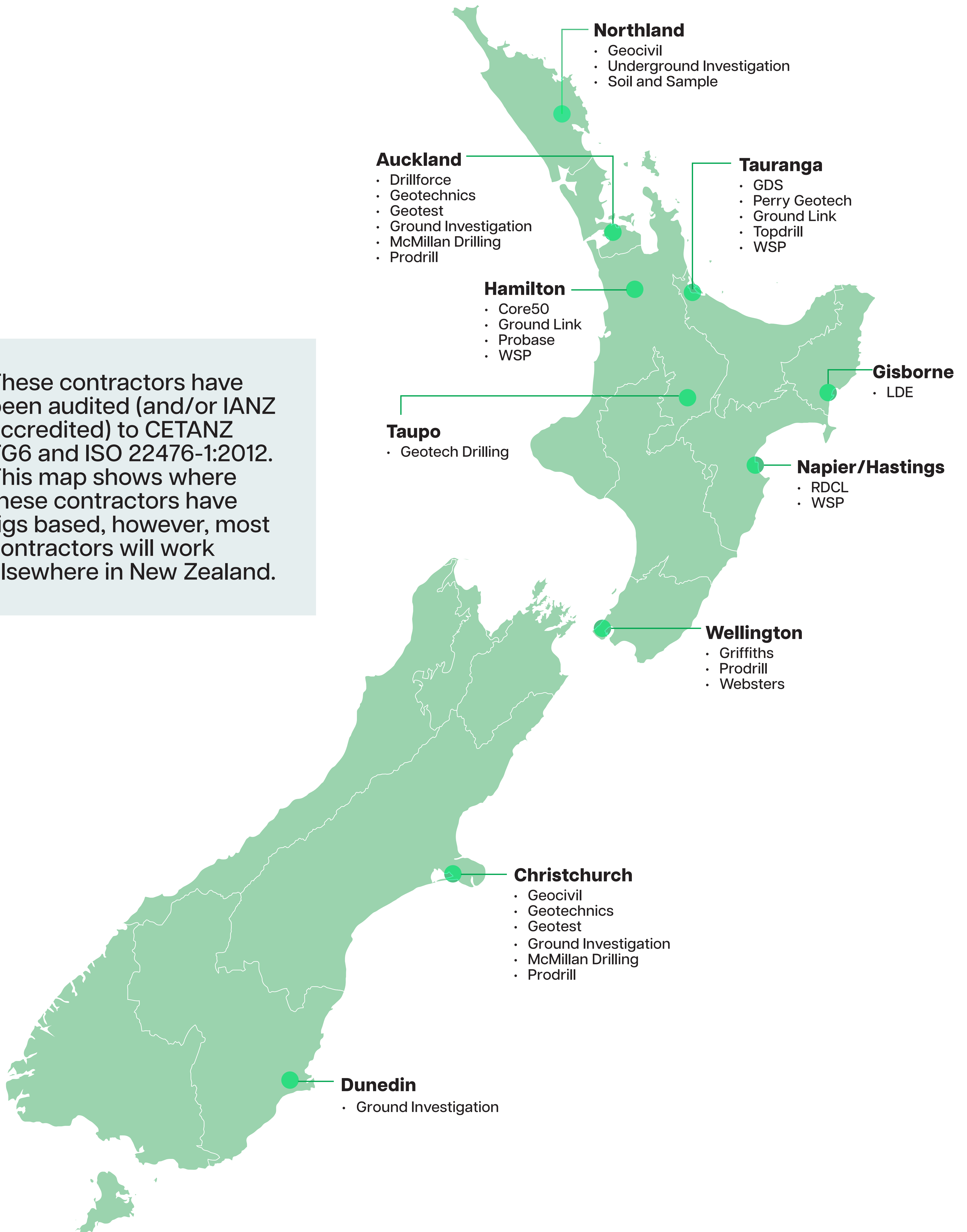

CETANZ CPT Group

The CPT Group is a working group of the Civil Engineering Testing Association of New Zealand (CETANZ). The group is an industry body formed to represent CPT Contractors in New Zealand and to continually improve the standard and status of CPT testing.

The Group, as the industry body, has adopted ISO 22476-1:2012 as the standard to which all CPT testing should be done to in New Zealand. The CPT Group has developed a best practice guideline (TG6) to ensure contractors maintain consistency in their methodologies under the ISO 2012 standard.

Almost all CPT contractors in New Zealand are members of this group and most of those have been through an auditing process to ensure a consistent and high quality of testing. Some others have IANZ Accreditation for TG6/ISO 2012. It is highly recommended that only those contractors that have passed the auditing process or have IANZ Accreditation be used for CPT testing in New Zealand so as to ensure reliable results. This will be a requirement for most site investigation projects carried out in accordance with the New Zealand Ground Investigation Specification and/or a requirement of engineers and other stakeholders on most projects in the future.

The CPT Group encourages all CPT contractors to become members and participate in the auditing process. Audits are carried out using Auditors appointed from within the group. Audits are undertaken every 4 years, with the next round to be undertaken in 2026.

The CPT group is also intending to organise training courses, hold seminars and promote CPT testing to the benefit of its members and to the wider geotechnical engineering industry.
